

NOTICE OF A RATE HEARING

Algoma Power Inc. has applied to change its electricity distribution rates and other charges

If the application is approved as filed, a typical residential customer and a typical general service customer of Algoma Power Inc. (Algoma Power) would see the following change effective January 1, 2025:

Residential (750 kWh)	-\$6.05 per month
General Service less than 50kW (2,000 kWh)	-\$2.23 per month
Seasonal (200 kWh)	\$10.48 per month

For residential customers, the customer bill impact includes the effect of the Distribution Rate Protection program.

Other customers, including businesses, will also be affected. It is important to review the application carefully to determine whether you may be affected by the proposed changes.

The above-noted bill impacts include the impact of Algoma Power's request to refund certain deferral and variance account balances in 2025.

Algoma Power has also applied for approval of two new deferral and variance accounts:

- Defined Benefit Pension Plan Variance Account
- Land Use Revenue Requirement Variance Account

Algoma Power also requests an order requiring the Independent Electricity System Operator to resettle certain accounts related to the Global Adjustment based on corrected information for May 2021 and January 2022.

YOU SHOULD KNOW

There are three types of OEB hearings: oral, electronic and written. The applicant has applied for a written hearing. The OEB is considering the request. If you think a different hearing type is needed, you can write to us to explain why.

This hearing will be held under section 78 of the **Ontario Energy Board Act, 1998**.

During this hearing, we will hear questions and arguments from participants about this case. We will also hear questions and arguments from participants that have registered as Intervenor. After the hearing, we will decide whether to approve the application.
